THE NOTES ON THE FOLLOWING PAGES GIVE AN EXPLANATION OF THE PROPOSED RESOLUTIONS.

All proposed Resolutions in this Notice will be voted on by way of a poll. Resolutions 1 to 13 are proposed as ordinary Resolutions. An ordinary Resolution will be passed on a poll if it is passed by shareholders representing more than 50 per cent. of the total voting rights of shareholders who vote. Resolutions 14 to 16 are proposed as special Resolutions. A special Resolution will be passed on a poll if it is passed by shareholders representing more than 75 per cent. of the total voting rights of shareholders who vote.

Ordinary Resolutions

To receive the Annual Report and Accounts 2023

Resolution 1 is a standard Resolution. The Companies Act 2006 requires the Directors to lay before the Company in a general meeting copies of the Company's annual accounts, the Directors' report and the auditor's report on those accounts. The Annual Report and Accounts for the year ended 31 March 2023 along with a copy of the AGM notice will be available online at www.brickabilitygroupplc.com.

Remuneration Report

Resolution 2 seeks shareholders' approval for the Directors' Remuneration report which is set out on pages 53 to 57 of the Annual Report and Accounts for year ended 31 March 2023. The vote is advisory only.

Final Dividend

In Resolution 3 the Directors are recommending the payment of a final dividend of 2.15 pence per ordinary share in respect of the year ended 31 March 2023. If approved at the AGM, the dividend will be paid on 21 September 2023 to shareholders who are on the Register of Members at the close of business on 25 August 2023.

Election and re-election of Directors

In line with the practice adopted by the Company in previous years, all Directors will be standing for election. Resolutions 4 to 9 seek approval for the re-election of those Directors who were in office during the year ended 31 March 2023. Resolution 10 deals with the appointment of Sharon Daly (née Collins) who was appointed as a non-executive director of the Company on 6 September 2022. Biographical information is provided on pages 40 and 41 of the Annual Report and Accounts for the year ended 31 March 2023 for each of the existing directors.

The Board has no hesitation in recommending the election of the Directors to shareholders. In making these recommendations, the Board confirms that it has given careful consideration to the Board's balance of skills, knowledge and experience and is satisfied that each of the Directors putting themselves forward for election has sufficient time to discharge their duties effectively, taking into account their other commitments.

Appointment of the auditor

The auditor of a company must be appointed or re-appointed at each general meeting at which the accounts are laid before shareholders. Resolution 11 seeks approval to re-appoint BDO LLP as the Company's auditor.

Remuneration of the auditor

Resolution 12 seeks consent for the Directors to determine the remuneration of the auditor.

Directors' authority to allot shares

Resolution 13 seeks consent for shareholders to grant the Directors authority to allot shares or grant rights to subscribe for or convert securities into shares, up to an aggregate nominal value of £2,001,710, which is approximately two-thirds of the nominal value of the issued ordinary share capital of the Company as at 30 June 2023, being the latest practicable date prior to the publication of this notice. £1.000.855 of this authority is reserved for a fully pre-emptive rights issue. This is the maximum permitted amount under best practice corporate governance guidelines.
